**Exchange of Notes concerning the Amendment to the Appendix to the Agreement between
the Republic of Korea and Japan concerning the Joint Development of the Southern Part
of the Continental Shelf adjacent to the Two Countries**

The Ambassador of Japan to the Minister of Foreign Affairs

Seoul, August 31, 1987

Excellency,

I have the honour to refer to paragraph 2 of Article III of the "Agreement between Japan and the Republic of Korea concerning Joint Development of the Southern Part of the Continental Shelf Adjacent to the Two Countries signed at Seoul on January 30, 1974 (hereinafter referred to as "the Agreement").

I have further the honour to propose, on behalf of the Government of Japan, that the Appendix to the Agreement be replaced by the Appendix attached hereto.

I have further the honour to propose that if the above proposal is acceptable to the Government of the Republic of Korea, the present Note and Your Excellency 's Note in reply to that effect shall be regarded as constituting an agreement between the two Governments and that the agreement shall enter into force on the date of Your Excellency 's Note in reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
